



Before



The manufacturer of photographic equipment used to release new models of one product line once in two years, each time issuing certificates of conformity and undergoing annual inspection for several certificates accordingly.

After



Based on the configuration and working principle – all cameras were equipped with a unified charger – we issued one declaration for the entire model range and one certificate for all the chargers. Only declarations were issued for the new camera models.

Registration of permits for spare parts every time they are imported




A telecommunications equipment distributor often imported spare parts for its products that were already certified.

Each time the customs authority asked the one for a permitting document for these spare parts, and each time the distributor issued it

After

Versatile response to customs requests





We have issued an information letter for customs, in which we justified the position that when importing spare parts, separate permits for them are not needed if there is a certificate for a complete product.



We have also made a respective request to the Ministry of Industry and Trade of the Russian Federation, and attached their response to this letter.
